### Owner's Pledge to BcWT

You agree to remove your dog from park if anti-social/rough play is displayed or prompted by BcWT staff.

You agree to leave treats and toys out of the park.

You agree to pick up after your dog if accidents happen.

You agree to the rules and regulations for providing accurate and true medical information.

You agree to never leave your dog unattended.

You agree to keep children, 6 yrs. and under, in the child play area and those over 6 by your side.

To maintain quality standards, failure to comply will result in you being asked to leave the park for the day w/o refund.

# Legal Agreement

By signing on the line below, you agree to the terms and conditions below:

1. Owner certifies the accuracy of all information Owner has conveyed about Owner's pet to BcWT (BcWT).
  2. Owner represents to BcWT that all credit card information Owner has provided to BcWT is accurate. Owner further represents that all information that Owner has given to BcWT about Owner is accurate. Daycare packages purchased must be used by the expiration date and are non-refundable.
  3. Owner agrees that if Owner's pet becomes ill or seems to be in need of medical consideration, BcWT, at its sole discretion, reserves the right to administer aid and/or to engage the services of a veterinarian and the expenses thereof shall be paid by the Owner. Owner gives consent to BcWT to act on the Owner's behalf in obtaining emergency veterinary care at the Owner's expense if deemed necessary by BcWT. Owner agrees to indemnify and holds BcWT and its employees harmless from said expenses.
  4. Owner understand that any problem, including but not limited to injury, illness or death that occurs while on our premises, all dog(s) will be treated as deemed best by the staff of BcWT, in their sole discretion, and that owner assumes full financial responsibility for any and all expenses involved.
  5. Owner agrees that their dog is in good general health, and valid proof that he/she is current on Rabies, DHLPP, Bordetella and Parvovirus vaccinations will be provided before she/he can stay at BcWT. In addition, Owner agrees that their dog is on a scheduled flea/tick prevention program. Dogs arriving with fleas will be refused service. Owners must show proof of negative fecal result, including negative Giardia result, within 2 weeks of dogs' hotel stay and within one month prior to starting daycare. Negative stools are required every 6 months to continue services.
  6. Owner hereby grants BcWT the right to videotape, photograph, and/or record their dog during their time at BcWT and to post and/or reproduce any and all photographs taken (as well as Owner's dog's name) on or in, without limitation, BcWT's website, promotional materials and merchandise, without becoming liable to the Owner or Owner's dog for any royalty payment of any kind. BcWT shall be the exclusive owner of the results and all such tapings, photography, and recordings will be used only by BcWT in its own promotion, advertising, sale or publicizing.
  7. Owner agrees that should their dog exhibit inappropriate aggressive behavior toward other dogs or employees, for the safety of all concerned he or she will be placed in a secure dog run and await the owners arrival for removal.
  8. In the event a dog is abandoned at BcWT, due diligence will be undertaken to locate the owner. If the owner cannot be located, the dog will be delivered to the nearest animal shelter.
  9. BcWT reserves the right to refuse any dog.
  10. BcWT shall exercise reasonable care for Owner's dog while Owner's dog is in BcWT's custody. Owner recognizes the potential risks involved group play/dog daycare, boarding and grooming due to the unpredictable nature of dogs. Owner recognizes that if their dog is asked to refrain from daycare play indefinitely, the daycare days left on packages are non-refundable.
  11. Owner further agrees that the pet shall not leave the facility until all charges due are paid by Owner or proper payment arrangement are agreed upon by both parties.
  12. Any claim or controversy arising out of or relating to this Contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any court having jurisdiction thereof. The arbitrator shall, as part of his/her award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney fees of the prevailing party.
  13. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and BcWT.
  14. BcWT reserves the right to charge an additional property damage fee, up to \$100, to owners whose dog(s) damage property. Property damage includes damage or destruction of beds, wall, flooring, equipment, etc. To avoid the potential of any unexpected fees, owners who believe their dog(s) may cause damage should speak with a BcWT Team Member to determine how best to accommodate the dog(s).
